SATISFACTION GUARANTEE

Seller guarantees that Buyer will be satisfied with the puppy purchased. This Satisfaction Guarantee is valid for three (3) days after you receive your puppy. If Buyer is not satisfied with the puppy received, Buyer will notify Seller and puppy may be returned to Seller within seven (7) days from receiving said puppy *at Buyer's cost*. Seller will replace the puppy of equal value from the next available litter or immediately if Seller has a puppy available or a full refund of the purchase price (**shipping cost, health certificate and kennel fees are NOT included in purchase price**) will be made *at Seller's option*.

HEALTH GUARANTEE

Seller states this puppy is a purebred German Shepherd of good health, and free of communicable diseases as far as Seller can see. This puppy has been checked by a veterinarian and was found to be healthy and has received one set of puppy shots (a puppy that is being picked up on the premises will NOT receive a set of puppy shots) and been treated for worms. *For any Guarantees in this Contract to be valid Buyer must have the puppy examined by their own veterinarian within three (3) days of receiving puppy unless otherwise stated and agreed to in writing on this Contract.* (Sunday is excluded, i.e. if you get your puppy on Sunday, you have until Wednesday to have it checked by your veterinarian) You will receive a replacement puppy from our next available litter if this puppy has any congenital defects which result in death or in its having to be euthanized within one year of this sale. **THIS DOES NOT INCLUDE CANINE PARVOVIRUS DISEASE (PARVO). THIS DOES NOT INCLUDE SHIPPING, HEALTH CERTIFICATE AND/OR KENNEL COSTS.** Buyer must notify Seller and provide a written report of the dog's health problem from Buyer's veterinarian to the Seller within seven (7) days of diagnoses, death or euthanization. **If Buyer does not notify and provide a written report from Buyer's veterinarian within seven (7) days of diagnoses, this Contract is VOID.** If puppy is euthanized, a certificate of euthanasia must be provided to Seller within seven (7) days of puppy being euthanized. The Buyer assumes full responsibility for all costs and care during this time. Seller is not responsible for pigment fade or beige color that may appear on the coat (very normal and can occur seasonally or in extreme weather conditions) and/or if another color other than white appears on the dog at any time and/or if one or both of the dog's ears do not stand up. The dogs health is not affected by this.

HIP GUARANTEE

Limited Registration: Buyer agrees to spay or neuter this puppy between the age of seven and nine months of age, but no later than the one year from the puppy's date of birth, and Buyer will mail to White Sand Kennels a veterinarian verification upon completion of that operation. It is the Buyer's responsibility to provide this documentation within 30 days of said operation. If said documentation is not provided in said time frame, this Contract is VOID. Within one (1) year from date of purchase, should your puppy develop hip dysplasia or any genetic skeletal disorder, which disorder will severely diminish your puppy's quality and enjoyment of life and necessitate euthanasia, upon receipt of (1) a letter from a duly licensed veterinarian attesting to such condition must be provided within seven (7) days of diagnoses; (2) a certificate of euthanasia; and (3) the puppy's AKC registration certificate, you will receive a replacement puppy from our next available litter. Buyer will pay all shipping costs, including health certificate and/or kennel if needed. A pet puppy who is found to have a mild condition when diagnosed, which does not require euthanasia, will NOT be replaced.

REGISTRATION REQUIREMENTS

Registration papers will be furnished to Buyer when complete payment is made for the puppy or when the registration papers are provided to Seller from the A.K.C. office. All registration papers will be held until the puppy has been paid for and all funds are clear. The Buyer has the option of naming their new dog with the exception that all puppies carry the kennel name "WSK's" at the front of their A.K.C. registered name (Ex: WSK's Princess Von Jewel). Buyer agrees to register this dog within 60 DAYS of ownership, as to the Date of Delivery on this Contract and send a copy of that registration to Seller within 30 days of receipt. ***If Buyer fails to use "WSK's" in front of the registered name, register dog in accordance with this paragraph or does not mail a copy of the registration and/or email proof of registration, all guarantees made by Seller in this contract will become void.***

BUYER AGREEMENT

Buyer agrees to notify Seller if the Buyer either chooses not to, or is unable to keep the dog for any reason. Buyer may give the puppy back to the Seller at any time, provided Seller has room for said puppy at their home. Seller may also help find a good home for said puppy if Buyer can no longer care for said puppy. Buyer also agrees to notify Seller of any O.F.A. results if Buyer has this test done (optional with Limited Registration) and if possible (as a courtesy) provide Seller with a copy of O.F.A. results for Seller's records. Buyer agrees to maintain current vaccinations and preventive medical care, proper food, water and lodging. Furthermore, Buyer agrees not to tie or chain the dog unless supervised by an adult at all times.

This guarantee is null and void for any of the following reasons:

- A. The dog changes ownership.
- B. The dog is bred knowingly or accidentally at anytime.
- C. Evidence of abuse is present.
- D. The dog is not A.K.C. registered within 60 days from the date of purchase and furnish seller a copy of said A.K.C. Registration papers.
- E. Any agreements in this Contract are not met.

If Buyer violates any part of this contract, all guarantees made by Seller in this Contract become VOID immediately. Furthermore, any legal action is to be in the county of the Seller's residence at time of claim.
